VTA's Transit-Oriented Development Access Study		

Comments, Issues, and Questions	Response		
I participated in an access study years ago. Is this going to supersede the transit study that I did before?	Station planning has been occurring over many years. In 2018-2019, VTA conducted access studies around three stations that resulted in Transit-Oriented Communities (TOC) playbooks, looking at broader strategies within one-half mile of each station. This current study is focusing on development of the lot behind the Downtown San Jose station. It is a continuation of the previous study's effort.		
	City of San Jose's Reimagining Santa Clara Street Vision Study		
Was there a study done in 2018? East Santa Clara vision study – recommendations for building height and sidewalk width. If we spend a lot of time on those things, I assume that the input would get looked at and not just put away.	We are more focused on transportation and public space on this one. We are aiming to solidify previous efforts and bring them to fruition with a full design for the corridor. The study [referenced] looked at access around a mile away from our stations. One of the key differences is that VTA made high level recommendations. The City, who is responsible for making these changes, is now taking it to a higher design level. VTA partnered with the City to identify strategies and funding but did not focus on advanced design of the corridor.		
Promise me that you're going to refer to that study and not duplicate efforts with something that was done many years ago.	Comment noted.		
It looks like a very intense study. We're fortunate to have the Guadelupe River project right next door and having that opportunity to upgrade is important because it connects to so many things. The point of this study really seems like an opportunity to energize Santa Clara Street and increase walkability. It might be a great idea to look at connecting streets to improve walkability and general mobility for bikes and other modes of transit, not just the main street.	Thank you for the feedback. We agree that the Guadelupe Parkway is an important area, in addition to the SJSU area as well. We want to make a convenient connection but also a memorable connection. In some places, we can take parking away and relocate it to these perpendicular streets as you mentioned.

Phase II Update		
I'm not sure I understand the plan to let red states go first. Could you please explain that further? Are there projects in the pipeline that are good candidates to submit before this project?	We entered into the New Starts engineering program and heard from FTA in August that we would be awarded \$5.1B for the program. We had planned to submit our FFGA readiness document in April 2025. The suggestion from our federal lobbyists was to not be the first project to apply under this administration. There are a few other projects in the pipeline (noted Utah). VTA is seriously considering this guidance while continuing to balance the project's budget.	
Aligning the Project with Available Fund		
On the 28th Street/Little Portugal parking structure, what has been VTA's experience with the parking facility at Berryessa versus what was planned? Is it being used at the predicted level? Is this saying that VTA does not think as many parking spaces will be used? Or is this just the first parking structure?	We are committed to providing 1,200 parking spaces but without a garage.	
Which section of the tunnel will be shallower?	This is a high-level study so we do not have exact numbers, but from my understanding, it would be shallower at the East portal and at 28th Street Station. We would still need to maintain the ability to go under the creek.	
In Task Force A alternative ( <i>concurrent tunneling from the East, with a fully cut/cover station</i> ), would the station design be totally different than the previous design?	The station experience would be the exact same. The boarding platforms would be on the side with trains going in the middle. The switchbacks would change to cascading escalators.	

Comments, Issues, and Questions	Response
And will the station design stay the same?	Yes, to the best of our ability the station's design will stay the same. The diagram below shows a much more similar configuration to what was shown in 2022.
